

M & S CHEVROLET

One of the most distastrous fires in recent years occurred here last Thursday night when fire broke out in the M. & S. Chevrolet Garage about 11 o'clock. The fire department responded promptly but the fire had gained quite a headway and the smoke was so dense that it was impossible to locate the blaze for quite some time.

The entire interior of the garage was badly gutted and much damage was done to the inside of the building as well as to all the stock and equipment. Several new tractors were badly scorched and damaged. The tires were badly burned on some of them and several cars were also damaged, although most of the cars and tractors were removed before they were severely burned.

Much damage was done to all of the tools, stock and most of their equipment. The heat became so intense that it even broke the glass in the office.

It took the fire department nearly an hour to get the blaze under control, and the cause of the fire is unknown.

October 5, 1944

Across the street, the M. & Chevrolet Garage people are remodeling the buildings purchased recently from Davis and Moore, and when completed will house the garage until the war is over when further remodeling will be done.






